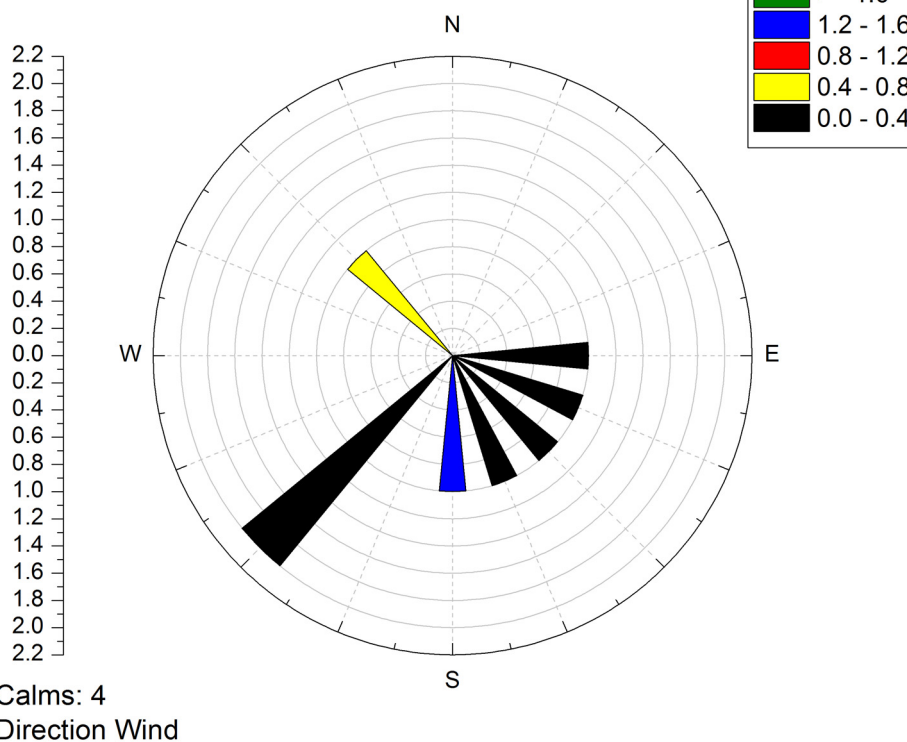


Figure S1. Prevailing wind speed and wind direction during the study period at the observation site.
