By integrating circular economy principles, such as recycling, reusing, and repurposing packaging materials, this study aims to identify strategies that optimize material flows, minimize waste, and promote a more sustainable approach to inventory management.

Overall, this research not only addresses the challenges of packaging material inventory management and sustainability, but also highlights the potential of Industry 4.0 in revolutionizing these areas within the food industry.
